Article 5: Overlay Districts; Subsections 5.2.4.8., 5.2.4.10, 5.2.4.15. and 5.2.6.2.5. Conditional Uses:

Are you in favor of the adoption of Amendment No. 1 as proposed by the Planning Board for the Town Zoning Ordinance as follows: To amend Article 5: Overlay Districts specifically to amend Subsection 5.2.4.8 DEFINITIONS to amend the definition of Impervious Surface as follows: A surface through which regulated substances cannot pass when spilled. Impervious surfaces include concrete unless unsealed cracks or holes are present. Asphalt; earthen, wooden, or gravel surfaces; or other surfaces which could react with or dissolve when in contact with the substances stored on them are not considered impervious for the express purpose of retaining the regulated substances, however these surfaces are considered impervious for the calculation of stormwater impacts and other regulatory calculations separate from the retention of spills. (03/24); FURTHER to amend Subsection 5.2.4.10 DEFINITIONS to amend the definition of Outdoor Storage as follows: Storage of materials where they are not protected by the elements by a roof, walls, and a floor with a surface impervious to regulated substances. (03/24); FURTHER to amend Subsection 5.2.4.15 DEFINITIONS to amend the definition of Secondary Containment as follows: A structure such as a berm or dike with a surface impervious to regulated substances which is adequate to hold at least one-hundred ten percent (110%) of the volume of the largest regulated substances container that will be stored there. (03/24); and FURTHER to amend Subsection 5.2.6.2.5, Conditional Uses as follows: All regulated substances stored in containers with a capacity of more than 5 gallons must be stored in product-tight containers on a surface impervious to regulated substances designed and maintained to prevent flow to exposed soils, floor drains, and outside drains. (03/24)



### **Dedication for 2024 Annual Report**

The "Hoelzel" name first appeared on the voter checklist over fifty years ago, as David and Kathy bought the old Dudley homestead in 1969. The Hoelzels call it "Littlewoods Farm." Raymond was well known to David as he had spent some of his early years as a Boy Scout at *Camp Onway*.

David wasted no time becoming involved in the town, volunteering for Scouts and more. In 1973 he was the leader in organizing the Raymond Town Fair, a post he held for 33 years assisted by his wife Kathy and family. The Hoelzels were early members of the Raymond Historical Society, formed in 1973, and David served in many ways over the years, including as president from 2014 until 2023, when Kathy was elected president. David was a leader in the Town's 225th Anniversary committee in 1989 and the 250th Anniversary committee in 2014.



Kathy, a mother of five boys and one girl, upon their arrival in Raymond from Lawrence in 1969 began her long years of service to the Town when she was elected to the school board in 1980, a post that she held until 1986, and again 1989-1992. Kathy also served on the Raymond High School building committee. In 1988, she filed for a seat in the N.H. House of Representatives, a post that she held for seventeen years (1989-1992 and 2009-2020). Following her tenure as Town Moderator from 1992 through 2019, she served as a member of the Board of Selectmen from 2019 to 2023. She was also a member of the Budget Committee from 1997 to 2001.

The only person to ever hold the Moderator position longer than Kathy is Moses Dudley, son of John Dudley, the Judge, one of the first settlers of Raymond and arguably one of our most notable early citizens. It is fitting that Dave and Kathy live in the Dudley homestead. John Dudley was Moderator for 20 years, first in 1767 and last in 1790. Moses Dudley was Moderator for 29 years, first in 1793 and last in 1833. Kathy served as Moderator for 27 years.

Dave and Kathy's roots run deep in Raymond. There hasn't been a town office or committee that in some way wasn't touched by their service.


