DPW ACTIVITIES/PROJECTS APRIL 1, 2024

The Department of Public Works is gearing up for a very busy 2024. Over the last 3 years the Town has fallen way behind on purchasing vehicles and equipment, getting roads paved, striping the roads, replacing culverts, providing training for staff members, and addressing other issues that have been neglected...so we have a lot to do. The following is a list of current projects/activities, in no particular order of importance:

Shattigee Road culvert work finished way ahead of schedule. Contractor has done a great job, the Town is very happy with the work. Final walk through is Monday the 1st at 9:00am and the road will be opened after that.

The Main Street Water Main Replacement is just about underway. Notices detailing the project were hand-delivered by DPW personnel to the area residents so they are aware of what to expect and when (see attached). There will be no parking at the end of the Common on Main Street and also the Horse Shed Municipal Lot due to construction staging. This work is expected to take approximately 5-6 weeks to complete. They will be starting the work at the bridge on Wednesday, April 3rd.

Street sweeping bid was posted mid March, public bid opening is taking place at the DPW office at 2:00pm tomorrow (April 2nd). Hoping to get the work done in the spring.

The <u>paving bid</u> also went out mid March, public bid opening is taking place at the DPW office at 2:00pm on Wednesday, April 10th. Bid includes the "gateway" streets into Town: Epping Street, Old Manchester Road from Main Street to the 101 on ramp, Wight Street, Church Street and Main Street from the bridge all the way to Route 102 (after water main work), and the Town Hall parking lot.

A bid was put out at the end of February for the <u>cleaning of Lagoon #1</u> at the Water Treatment Plant. This is done approximately every five years and is required to keep the lagoons clean so the sludge doesn't push further into the ground and contaminate the wells years down the road. The public bid opening is taking place at the DPW office at 2:00pm on Thursday, April 4th. We are estimating the cost of this work to be approximately \$65,000. We will be coming before the Board to expend funds for this from the Construction/Repair & Maintenance of WTP CRF, which currently has a balance of \$213,004.

A bid was put out at the end of February for the <u>cleaning services for Well #4</u>, and the public bid opening took place at the DPW office at 2:00pm on March 21st. There was only one bid response, which was from Weston & Sampson for a price of \$32,500. Wells are routinely cleaned on a rotating schedule. Well 4 has not been cleaned since its installation in 2018 and this is a vital element to the proper performance of the well. As part of this cleaning, GZA will be conducting flow and water quality testing which will be included in the total cost for the work. We will be coming before the Board to expend funds for this from the Water System Infrastructure CRF, which currently has a balance of \$218,924.

The installation of the new <u>Town-wide telephone system</u> is underway. This was put out to bid back in September of 2023 and the company Telephone Network Technologies was awarded the bid at a cost of \$34,929.05. Almost all of the "cabling" has been done, they are now working on terminating the heads where the phone lines come in. They should be getting the phones in place soon. They are a little behind schedule due to employee illness.

<u>Capital Improvement Plans</u> (CIP's) have been submitted; one for Public Works and one for the Water Department. Focus is on replacing equipment and vehicles, and paving.

A "kick-off" meeting has been scheduled for April 24th to move forward with the <u>MS4/Asset</u> <u>Management program</u>. This had been stalled due to a lack of a DPW Director in place. The Town received a grant for \$30,000 through the Clean Water State Revolving Fund Loan Program to purchase asset management software to assist with data collection related to MS4.

<u>Household Hazardous Waste Collection Day</u> is scheduled for Saturday, April 27th, from 8am to 12pm on Industrial Drive off of Exit 4. We have a meeting scheduled with the company that does the collection tomorrow at 10:00.

The entire DPW is scheduled to attend mandatory Town-wide <u>Harassment and Ethics training</u> this week. Also looking into upcoming training through Primex and NHMA.

The Water Department finished up with reading quarterly meters last week so the <u>water billing</u> process began today. If all goes well, it typically takes 2-3 days to complete the entire process and bills will be mailed out next week.

Hydrant flushing starts tomorrow and will be happening every Tuesday and Thursday in the month of April. This flushing process can occasionally cause dirty water and low pressure in the system. The Water Department recommends that all system users flush out their water heater tanks at this time. We apologize for any inconvenience and thank all the customers for their cooperation.

The Town is in the process of transitioning over to a <u>new Website</u>. Training is ongoing for staff to be able to post items to their own Department pages. The DPW page may be a bit behind until we get some administrative support on board, but the goal is to post pictures and information on a regular basis and keep the information up to date.

This year, we will need to do a Master Control Panel Replacement at the Water Treatment Plant (WTP). This controls all of the WTP functions and is vital to its operation. This should typically be replaced every 10 years, however, the original system is still in place from 2004. The computer cards need to be changed out often and are also hard to come by as they are discontinued parts/items. Estimated cost for this is \$100,000. We will come before the Board to request funds from the Construction/Repair & Maint. of WTP CRF (current balance \$213,004).

Will be setting up training for DPW folks to learn how to enter <u>Work Orders into the Beehive</u> <u>Asset Management Software</u> we currently have. This software has proven to be extremely helpful to the Water Department. When entering work orders into the system, they are able to be tracked and followed up on in a timely manner.

We are working on getting quotes from several companies for pumping out the <u>Town's septic</u> <u>system</u>, which is a total of 9,000 gallons. Planning to get this scheduled for some time in April or May.

The Town has an executed <u>easement agreement</u> with Eversource for access to the Route 156 Tower for the upcoming rehab work. In the process now of acquiring a temporary driveway permit from the State DOT. When the time comes, the work will be done by our DPW staff.

Highway team will be scheduling <u>culvert work</u> in several locations around Town. These include: Blackberry Lane, Otter Court, and Merrick Road.

The <u>irrigation system</u> is going to be replaced at the Town Common. This work will be scheduled accordingly around the water line work on Main Street.

TOWN OF RAYMOND, NH 2024 MAIN STREET WATER MAIN REPLACEMENT PROJECT

Dear Residents of Main Street:

The Town of Raymond is beginning construction on the Main Street Water Main Replacement Project to renovate the water distribution system. These renovations will allow the Department of Public Works to continue to provide an ample volume of good quality water to Raymond residents. Residents can expect that the water main installation will occur on Main Street within the next few weeks. To help coordinate construction issues and to address concerns from residents, a personnel member from the design engineering firm will be located at the construction site for the duration of the project.

IMPROVING YOUR WATER SYSTEM

The work involved in replacing the water main in your street consists of excavating and installing the new 12" ductile iron water main. Prior to the existing water main being abandoned, your residence will be transferred to the new main once all pressure and leakage tests and disinfection tests have passed. The Town's contractor (Joseph P. Cardillo and Son, Inc.) will need to temporarily access your property to complete the service connection and ensure the water service is functioning properly and flushed. A notice will be distributed to you approximately 24 hours in advance of this activity.

Once the new main has been completely installed and has passed a pressure and leakage test and a disinfection test, the contractor will shut off water to your house for approximately 2 hours to connect your existing water service to the new water main. Throughout the construction, we will make every effort to ensure that your normal water service is always maintained. However, there may be times when it will be necessary to shut down the water completely. When this happens, the length of time that you are without water will be less than 4-hours each and should be limited to a few periods during various water main and service connections. You will receive approximately 24-hours notice prior to all planned water service interruptions.

HOW WILL THIS WORK AFFECT YOU?

Construction will take place during the day between 7:00 am and 5:00 pm, Monday through Friday. While the work is in progress, residences and businesses along the route will be somewhat inconvenienced by the presence of construction equipment and excavations on your street. It is likely that during the installation of the water main that the street will be closed during construction except to local traffic. During excavations, access to your driveways may be limited or blocked for a short period of time. During these instances we will make the inconvenience as minor as possible and there will be a resident representative from the design engineering firm on site during construction to assist you in always maintaining access to your business and house.

We apologize in advance for the inconvenience. Construction activities regarding the replacement of the water main in Main Street are anticipated to begin as soon as March 25, 2024. We expect that the construction on Main Street will take approximately 6 weeks before it is complete.

PLEASE... BE CAREFUL

We realize that this water main replacement project will cause some inconvenience for those who live and work in the area. We are working closely with your local officials and public departments to keep traffic problems to a minimum and to observe all safety precautions. All open excavations will be adequately safeguarded by providing temporary barricades, cautions signs, and lights, but Please ... USE EXTRA CAUTION!

IF YOU HAVE A PROBLEM...

If <u>emergencies</u> arise such as a broken water pipe or no water to your house, residents are requested to call an emergency phone number at 603-895-4222. This telephone number should be used <u>only for emergency</u> situations.

Non-emergency calls to answer questions that you may have should be made to the Dept. of Public Works between the hours of 8:00 a.m. and 4:00 p.m. on weekdays. The number is (603) 895-7036.

Thank you for your patience and cooperation while work is being conducted to improve your water system.

Hi Julie...

The Parks Department is requesting the expenditure of funds from the "Parks Dept. Equipment, Vehicle and Facilities CRF" in the amount of \$19,606.20.

This mower is needed to replace the old Hustler Super Z 6' mower. The Parks Dept. currently has a 2022 6' Hustler and a 2020 Hustler that is in need of work before this coming season.

We have a 2020 Toro that is used for snow removal via a broom/sweeper and/or snow hlower, and is also used as a sweeper in the spring in the downtown area. This unit has proved to work very well for snow removal and as a sweeper for cleaning sand off sidewalks in the spring, however, as a mower the quality and performance has not been the best with the lack of power and the grass collection system is slow and time consuming. Also, it is very time consuming for our Fleet Department to switch from winter mode to summer/mowing mode. The Toro was purchased years ago by a former Town Manager and DPW director in a way to buy one machine to use for two seasons. The Parks and Highway Depts would like to keep the Toro as a winter machine only with the ability to use the sweeper broom during spring and summer as needed.

The Parks Dept. needs to have three 6' mowers in its fleet to efficiently get all areas mowed multiple times a week in order to keep the grass at a safe, playable height and have time to take eare of other matters.

Attached is the RFP that was posted on March 1st along with the public opening of the bids and the award. We are planning to attend the BOS meeting on April 1st to request these funds in person and to answer any questions the Board may have.

At 1:00pm on Wednesday, March 20th, the Town Manager, the DPW Director, Brian Arnold our Parks Foreman and Exec. Asst. Jackie Sampson were present to publicly open bids for the Zero Turn Mower that was put out on March 1st.

Two bids were received:

Perkins Power Equipment out of Exeter \$19,606.20

Richey & Clapper out of Sudbury, MA \$21,057.29

Both bids were for a Hustler Super Z Hyperdrive 72" Mower with 40 HP Vanguard Oil Engine with a dump collection system and striping kit.

Perkins mower is available for delivery 7 business days upon bid award R & C mower is available for delivery 30 days after receipt of order

The group unanimously awarded the bid to Perkins Power Equipment.

It is the intent of the Town to enter into an agreement, through its Director of Public Works or his/her designee with the selected dealer for the replacement of a 72" Zero Turn Mower.

Deadline for submittal is <u>Wednesday, March 20, 2024 at 1:00pm</u> at which time bids will be opened in public at the Department of Public Works office located at 4 Epping Street in Raymond.

Each bid must be submitted in a sealed envelope addressed to Stacey Grella, Department of Public Works, 4 Epping Street, Raymond, New Hampshire 03077. Each sealed envelope containing "Bid" must be plainly marked on the outside as "2024 Bid for Zero Turn Mower".

Attached are three quotes for a 10-wheeler truck for the Highway Department. 3. EFFECTIVE DATE/COMPLETION OF SERVICES.

3.1 Notwithstanding any provision of this Agreement to the contrary, and subject to the approval of the Governor and Executive Council of the State of New Hampshire, if applicable, this Agreement, and all obligations of the parties hereunder, shall become effective on the date the Governor and Executive Council approve this Agreement as indicated in block 1.17, unless no such approval is required, in which case the Agreement shall become effective on the date the Agreement is signed by the State Agency as shown in block 1.13 ("Effective Date").

3.2 If the Contractor commences the Services prior to the Effective Date, all Services performed by the Contractor prior to the Effective Date shall be performed at the sole risk of the Contractor, and in the event that this Agreement does not become effective, the State shall have no liability to the Contractor, including without limitation, any obligation to pay the Contractor for any costs incurred or Services performed. Contractor must complete all Services by the Completion Date specified in block 1.7.

4. CONDITIONAL NATURE OF AGREEMENT.

Notwithstanding any provision of this Agreement to the contrary, all obligations of the State hereunder, including, without limitation, the continuance of payments hereunder, are contingent upon the availability and continued appropriation of funds affected by any state or federal legislative or executive action that reduces, climinates or otherwise modifies the appropriation or availability of funding for this Agreement and the Scope for Services provided in EXHIBIT B, in whole or in part. In no event shall the State be liable for any payments hereunder in excess of such available appropriated funds. In the event of a reduction or termination of appropriated funds, the State shall have the right to withhold payment until such funds become available, if ever, and shall have the right to reduce or terminate the Services under this Agreement immediately upon giving the Contractor notice of such reduction or termination. The State shall not be required to transfer funds from any other account or source to the Account identified in block 1.6 in the event funds in that Account are reduced or unavailable.

5. CONTRACT PRICE/PRICE LIMITATION/ PAYMENT.

5.1 The contract price, method of payment, and terms of payment are identified and more particularly described in EXHIBIT C which is incorporated herein by reference.

5.2 The payment by the State of the contract price shall be the only and the complete reimbursement to the Contractor for all expenses, of whatever nature incurred by the Contractor in the performance hereof, and shall be the only and the complete compensation to the Contractor for the Services. The State shall have no liability to the Contractor other than the contract price.

5.3 The State reserves the right to offset from any amounts otherwise payable to the Contractor under this Agreement those liquidated amounts required or permitted by N.H. RSA 80;7 through RSA 80;7-c or any other provision of law.

5.4 Notwithstanding any provision in this Agreement to the contrary, and notwithstanding unexpected circumstances, in no

event shall the total of all payments authorized, or actually made hereunder, exceed the Price Limitation set forth in block 1.8.

6. COMPLIANCE BY CONTRACTOR WITH LAWS AND REGULATIONS/ EQUAL EMPLOYMENT OPPORTUNITY.

6.1 In connection with the performance of the Services, the Contractor shall comply with all applicable statutes, laws, regulations, and orders of federal, state, county or municipal authorities which impose any obligation or duty upon the Contractor, including, but not limited to, civil rights and equal employment opportunity laws. In addition, if this Agreement is funded in any part by monies of the United States, the Contractor shall comply with all federal executive orders, rules, regulations and statutes, and with any rules, regulations and guidelines as the State or the United States issue to implement these regulations. The Contractor shall also comply with all applicable intellectual property laws.

6.2 During the term of this Agreement, the Contractor shall not discriminate against employees or applicants for employment because of race, color, religion, creed, age, sex, handicap, sexual orientation, or national origin and will take affirmative action to prevent such discrimination.

6.3. The Contractor agrees to permit the State or United States access to any of the Contractor's books, records and accounts for the purpose of ascertaining compliance with all rules, regulations and orders, and the covenants, terms and conditions of this Agreement.

7. PERSONNEL.

7.1 The Contractor shall at its own expense provide all personnel necessary to perform the Services. The Contractor warrants that all personnel engaged in the Services shall be qualified to perform the Services, and shall be properly licensed and otherwise authorized to do so under all applicable laws.

7.2 Unless otherwise authorized in writing, during the term of this Agreement, and for a period of six (6) months after the Completion Date in block 1.7, the Contractor shall not hire, and shall not permit any subcontractor or other person, firm or corporation with whom it is engaged in a combined effort to perform the Services to hire, any person who is a State employee or official, who is materially involved in the procurement, administration or performance of this Agreement. This provision shall survive termination of this Agreement.

7.3 The Contracting Officer specified in block 1.9, or his or her successor, shall be the State's representative. In the event of any dispute concerning the interpretation of this Agreement, the Contracting Officer's decision shall be final for the State.

8. EVENT OF DEFAULT/REMEDIES.

- 8.1 Any one or more of the following acts or omissions of the Contractor shall constitute an event of default hereunder ("Event of Default"):
- 8.1.1 Failure to perform the Services satisfactorily or on schedule;
- 8.1.2 Failure to submit any report required hereunder; and/or
- 8.1.3 Failure to perform any other covenant, term or condition of this Agreement.

8.2 Upon the occurrence of any Event of Default, the State may take any one, or more, or all, of the following actions:

8.2.1 Give the Contractor a written notice specifying the Event of Default and requiring it to be remedied within, in the absence of a greater or lesser specification of time, thirty (30) days from the date of the notice; and if the Event of Default is not timely cured, terminate this Agreement, effective two (2) days after giving the Contractor notice of termination;

8.2.2 Give the Contractor a written notice specifying the Event of Default and suspending all payments to be made under this Agreement and ordering that the portion of the contract price which would otherwise accrue to the Contractor during the period from the date of such notice until such time as the State determines that the Contractor has cured the Event of Default shall never be paid to the Contractor;

8.2.3 Give the Contractor a written notice specifying the Event of Default and set off against any other obligations the State may owe to the Contractor any damages the State suffers by reason of any Event of Default; and/or

8.2.4 Give the Contractor a written notice specifying the Event of Default, treat the Agreement as breached, terminate the Agreement and pursue any of its remedies at law or in equity, or both.

8.3. No failure by the State to enforce any provisions hereof after any Event of Default shall be deemed a waiver of its rights with regard to that Event of Default, or any subsequent Event of Default. No express failure to enforce any Event of Default shall be deemed a waiver of the right of the State to enforce each and all of the provisions hereof upon any further or other Event of Default on the part of the Contractor.

9. TERMINATION.

9.1 Notwithstanding paragraph 8, the State may, at its sole discretion, terminate the Agreement for any reason, in whole or in part, by thirty (30) days written notice to the Contractor that the State is exercising its option to terminate the Agreement.

9.2 In the event of an early termination of this Agreement for any reason other than the completion of the Services, the Contractor shall, at the State's discretion, deliver to the Contracting Officer, not later than fifteen (15) days after the date of termination, a report ("Termination Report") describing in detail all Services performed, and the contract price earned, to and including the date of termination. The form, subject matter, content, and number of copies of the Termination Report shall be identical to those of any Final Report described in the attached EXHIBIT B. In addition, at the State's discretion, the Contractor shall, within 15 days of notice of early termination, develop and submit to the State a Transition Plan for services under the Agreement.

10. DATA/ACCESS/CONFIDENTIALITY/ PRESERVATION.

10.1 As used in this Agreement, the word "data" shall mean all information and things developed or obtained during the performance of, or acquired or developed by reason of, this Agreement, including, but not limited to, all studies, reports, files, formulae, surveys, maps, charts, sound recordings, video recordings, pictorial reproductions, drawings, analyses, graphic representations, computer programs, computer printouts, notes,

10.2 All data and any property which has been received from the State or purchased with funds provided for that purpose under this Agreement, shall be the property of the State, and shall be returned to the State upon demand or upon termination of this Agreement for any reason.

10.3 Confidentiality of data shall be governed by N.H. RSA chapter 91-A or other existing law. Disclosure of data requires prior written approval of the State.

11. CONTRACTOR'S RELATION TO THE STATE. In the performance of this Agreement the Contractor is in all respects an independent contractor, and is neither an agent nor an employee of the State. Neither the Contractor nor any of its officers, employees, agents or members shall have authority to bind the State or receive any benefits, workers' compensation or other emoluments provided by the State to its employees.

12. ASSIGNMENT/DELEGATION/SUBCONTRACTS.

12.1 The Contractor shall not assign, or otherwise transfer any interest in this Agreement without the prior written notice, which shall be provided to the State at least fifteen (15) days prior to the assignment, and a written consent of the State. For purposes of this paragraph, a Change of Control shall constitute assignment. "Change of Control" means (a) merger, consolidation, or a transaction or series of related transactions in which a third party, together with its affiliates, becomes the direct or indirect owner of fifty percent (50%) or more of the voting shares or similar equity interests, or combined voting power of the Contractor, or (b) the sale of all or substantially all of the assets of the Contractor.

12.2 None of the Services shall be subcontracted by the Contractor without prior written notice and consent of the State. The State is entitled to copies of all subcontracts and assignment agreements and shall not be bound by any provisions contained in a subcontract or an assignment agreement to which it is not a party.

13. INDEMNIFICATION. Unless otherwise exempted by law, the Contractor shall indemnify and hold harmless the State, its officers and employees, from and against any and all claims, liabilities and costs for any personal injury or property damages, patent or copyright infringement, or other claims asserted against the State, its officers or employees, which arise out of (or which may be claimed to arise out of) the acts or omission of the Contractor, or subcontractors, including but not limited to the negligence, reckless or intentional conduct. The State shall not be liable for any costs incurred by the Contractor arising under this paragraph 13. Notwithstanding the foregoing, nothing herein contained shall be deemed to constitute a waiver of the sovereign immunity of the State, which immunity is hereby reserved to the State. This covenant in paragraph 13 shall survive the termination of this Agreement.

- 15.2 To the extent the Contractor is subject to the requirements of N.H. RSA chapter 281-A, Contractor shall maintain, and require any subcontractor or assignee to secure and maintain, payment of Workers' Compensation in connection with activities which the person proposes to undertake pursuant to this Agreement. The Contractor shall furnish the Contracting Officer identified in block 1.9, or his or her successor, proof of Workers' Compensation in the manner described in N.H. RSA chapter 281-A and any applicable renewal(s) thereof, which shall be attached and are incorporated herein by reference. The State shall not be responsible for payment of any Workers' Compensation premiums or for any other claim or benefit for Contractor, or any subcontractor or employee of Contractor, which might arise under applicable State of New Hampshire Workers' Compensation laws in connection with the performance of the Services under this Agreement.
- 16. NOTICE. Any notice by a party hereto to the other party shall be deemed to have been duly delivered or given at the time of mailing by certified mail, postage prepaid, in a United States Post Office addressed to the parties at the addresses given in blocks 1.2 and 1.4, herein.
- 17. AMENDMENT. This Agreement may be amended, waived or discharged only by an instrument in writing signed by the parties hereto and only after approval of such amendment, waiver or discharge by the Governor and Executive Council of the State of New Hampshire unless no such approval is required under the circumstances pursuant to State law, rule or policy.

- 18. CHOICE OF LAW AND FORUM. This Agreement shall be governed, interpreted and construed in accordance with the laws of the State of New Hampshire, and is binding upon and inures to the benefit of the parties and their respective successors and assigns. The wording used in this Agreement is the wording chosen by the parties to express their mutual intent, and no rule of construction shall be applied against or in favor of any party. Any actions arising out of this Agreement shall be brought and maintained in New Hampshire Superior Court which shall have exclusive jurisdiction thereof.
- 19. CONFLICTING TERMS. In the event of a conflict between the terms of this P-37 form (as modified in EXHIBIT A) and/or attachments and amendment thereof, the terms of the P-37 (as modified in EXHIBIT A) shall control.
- 20. THIRD PARTIES. The parties hereto do not intend to benefit any third parties and this Agreement shall not be construed to confer any such benefit.
- 21. HEADINGS. The headings throughout the Agreement are for reference purposes only, and the words contained therein shall in no way be held to explain, modify, amplify or aid in the interpretation, construction or meaning of the provisions of this Agreement.
- SPECIAL PROVISIONS. Additional or modifying provisions set forth in the attached EXHIBIT A are incorporated herein by reference.
- 23. SEVERABILITY. In the event any of the provisions of this Agreement are held by a court of competent jurisdiction to be contrary to any state or federal law, the remaining provisions of this Agreement will remain in full force and effect.
- 24. ENTIRE AGREEMENT. This Agreement, which may be executed in a number of counterparts, each of which shall be deemed an original, constitutes the entire agreement and understanding between the parties, and supersedes all prior agreements and understandings with respect to the subject matter hereof.
