Zoning Amendment No. 1

Article 5: Overlay Districts; Subsections 5.2.4.8., 5.2.4.10, 5.2.4.15. and 5.2.6.2.5. Conditional Uses: Are you in favor of the adoption of Amendment No. 1 as proposed by the Planning Board for the Town Zoning Ordinance as follows: To amend Article 5: Overlay Districts specifically to amend Subsection 5.2.4.8 DEFINITIONS to amend the definition of Impervious Surface as follows: A surface through which regulated substances cannot pass when spilled. Impervious surfaces include concrete unless unsealed cracks or holes are present. Asphalt; earthen, wooden, or gravel surfaces; or other surfaces which could react with or dissolve when in contact with the substances stored on them are not considered impervious for the express purpose of retaining the regulated substances, however these surfaces are considered impervious for the calculation of stormwater impacts and other regulatory calculations separate from the retention of spills. (03/24); *FURTHER* to amend Subsection 5.2.4.10 DEFINITIONS to amend the definition of Outdoor Storage as follows: Storage of materials where they are not protected by the elements by a roof, walls, and a floor with a surface impervious to regulated substances. (03/24); FURTHER to amend Subsection 5.2.4.15 DEFINITIONS to amend the definition of Secondary Containment as follows: A structure such as a berm or dike with a surface impervious to regulated substances which is adequate to hold at least one-hundred ten percent (110%) of the volume of the largest regulated substances container that will be stored there. (03/24); and FURTHER to amend Subsection 5.2.6.2.5, Conditional Uses as follows: All regulated substances stored in containers with a capacity of more than 5 gallons must be stored in product-tight containers on a surface impervious to regulated substances designed and maintained to prevent flow to exposed soils, floor drains, and outside drains. (03/24)

Zoning Amendment No. 2

Article 5: Overlay Districts; 5.2.4. DEFINITIONS; Add Subsection 5.2.4.21. Wetland Buffer:

Are you in favor of the adoption of Amendment No. 2 as proposed by the Planning Board for the Town Zoning Ordinance as follows – To amend *Article 5: Overlay Districts specifically to amend Section 5.2.4. DEFINITIONS* by adding the following Subsection 5.2.4.21. "Wetland Buffer": Wetland buffer or wetland setback means a designated area contiguous or adjacent to a wetland that is required for the continued maintenance, function, and ecological stability of the wetland. DISTRICT BOUNDARIES; Subsection 4.9.3.1. to the following:* SHORELAND PROTECTION AREA: Is any area of land within seventy-five (75) feet of the seasonal high-water mark of any river, brook, lake or pond, or intermittent or perennial stream. Zoning Amendment No. 8

Article 13 DEFINITIONS: Solar Panels

Are you in favor of the adoption of Amendment No. 8 as proposed by the Planning Board for the Town Zoning Ordinance as follows: To amend *Article 13: DEFINITIONS* by *specifically adding the following Subsection named* "Solar Panel": A Solar Panel is a panel designed to absorb the sun's rays as a source of energy for generating electricity or heating. All Solar Panels are considered 100% impervious for the calculation of impervious surfaces. (03/24)

Article 9: Operating Budget

Shall the Town of Raymond vote to raise and appropriate as an Operating Budget, not including appropriations by Special Warrant Articles and other appropriations voted separately, the amounts set forth on the budget posted with the warrant, or as amended by vote of the first session, for the purposes set forth therein, totaling Ten Million, Four Hundred Sixty-Five Thousand, Six Hundred Ninety-Five Dollars (\$10,465,695)

Components of the budget include:

Should this article be defeated, the default budget shall be Ten Million, Two Hundred Seventeen Thousand, Two Hundred Ninety-Nine Dollars (\$10,217,299) which is the same as last year, with certain adjustments required by previous action of the Town of Raymond or by law; or the governing body may hold one special meeting, in accordance with RSA 40:13, X and XVI, to take up the issue of a revised operating budget only.

Article 11: Collective Bargaining Agreement

Shall the Town of Raymond, if Warrant Article 11 is defeated, authorize the governing body to call one special meeting, at its option, to address Warrant Article 11 cost items only. (Majority vote required.)

Article 12: Water Tower Rehabilitation

To see if the Town will vote to raise and appropriate the sum of One Million, Two Hundred One Thousand, Two Hundred Seventy-Four Dollars (\$1,201,274.) (gross budget) for the design, permitting, rehabilitation of the route 156 water tower, and perform related infrastructure improvements (the "Project"); to authorize (\$451,274) of such sum for the Project to come from the Water Department Unassigned Fund Balance already on hand; and to authorize (\$750,000.) of such sum for the project to come from the Towns Unassigned Fund Balance already on hand, and to authorize the Board of Selectmen to spend such funds.

<u>Article 14 – Bridge and Culvert Capital Reserve Fund Deposit – Deposit of Distribution received from the State of New Hampshire Department of Transportation of a one-time Bridge Payment:</u>

Shall the Town of Raymond vote to raise and appropriate the sum of Fifty-Six Thousand, Nine Hundred Eighty-One Dollars (\$56,981) to be deposited into the previously established Bridge and Culvert Capital Reserve Fund, naming the Board of Selectmen as agents to expend from said fund; this appropriation to come from unassigned fund balance. No amount to be raised by taxation. This is to transfer a special one-time allocation in the amount above specifically for maintenance, construction, and reconstruction of municipally owned bridges. <u>Article 16 – Town Road Revitalization Capital Reserve Fund:</u>

To see if the Town will vote to raise and appropriate the sum of One Hundred Fifty Thousand Dollars (\$150,000) to be placed in the Road Revitalization Capital Reserve Fund previously established under the provisions of RSA 35:1 for the purpose of supporting the Town's five-year strategic initiative to upgrade and render safe the Town's Road infrastructure systems. These funds are to be used in conjunction with the funds received from the Road Reconstruction Fund to return the Town roads to a maintainable condition. This sum is to come from the unassigned fund balance and no amount will be raised through future taxation. Further, to name the Board of Selectmen as agents to expend from said fund. (Majority Vote Required)

<u>Article 17 – Water Department Capital Reserve Funds Appropriations:</u>

These funds shall be paid by Water Revenues. (Majority Vote Required)

<u>Article 18 – Shim and Overlay Special Revenue Fund:</u>

Shall the Town of Raymond vote to raise and appropriate up to the sum of Three Hundred Twenty-one Thousand, One Hundred Ninety-Four Dollars (\$321,194) for road reconstruction. This would authorize the withdrawal of \$250,000 from the Shim and Overlay Special Revenue Fund created for this purpose, with the balance of \$70,194. to come from unassigned fund balance. No amount to be raised by taxation. This is a non-lapsing appropriation per RSA 32:7, VI and will not lapse until the Shim and Overlay work is complete or until December 31, 2026, whichever comes first. (Majority Vote Required)

<u>Article 19 – Road Reconstruction Projects:</u>

This will be a non-lapsing appropriation per RSA 32:7, VI and will not lapse until the road reconstruction work has been completed or by December 31, 2026, whichever comes first. This sum is to come from the unassigned fund balance and no amount will be raised through future taxation. (Majority Vote Required)

Article 22- Sick and Vacation Leave Non-Union Trust Fund

Shall the Town of Raymond vote to raise and appropriate the sum not to exceed Ten Thousand Dollars (\$10,000) to be added to the Sick and Vacation Leave Non-Union Expendable Trust Fund (established pursuant to Warrant Article #25 of the 2004 Town Meeting) for the purpose of paying out accrued time upon leave of employment as indicated in the Town of Raymond Personnel Policy for employees. And further that said set amount to come from unassigned fund balance and no amount from taxation. (Majority Vote Required)

<u>Article 26 – Establish Contingency Fund:</u>

To see if the town will vote to establish a contingency fund pursuant to RSA 31:98-a for the current year for unanticipated expenses that may arise and further to raise and appropriate the sum of Ninety-Five Thousand, Seven Hundred Two Dollars (\$95,702) from the unassigned fund balance to be placed in this contingency fund. Such a fund shall not exceed one percent (1%) of the amount appropriated by the town for town purposes during the preceding year excluding capital expenditures and the amortization of debt. Any appropriation left remaining in the fund at the end of the year will lapse to the general fund. A detailed report of all expenditures from the contingency fund shall be prepared annually by the Board of Selectmen and published with their report. (Majority vote required).

<u>Article 27– Stormwater Planning Project (CWSRF Loan):</u>

Shall the Town vote to raise and appropriate the sum of One Hundred Thousand Dollars (\$100,000) for the purpose of stormwater planning work relative to management of the municipal storm drain system in accordance with the 2017 NH Small MS4 General Permit, and to authorize the issuance of not more than \$100,000 of bonds or notes in accordance with the provisions of the Municipal Finance Act (RSA 33, as amended); to authorize the Board of Selectmen to issue and negotiate such bonds or notes and to determine the rate of interest thereon, and to further authorize the Board of Selectmen to offset a portion of said appropriation by applying for and accepting a Clean Water State Revolving Fund (CWSRF) loan, it being understood that repayment of the loan may include up to 100% principal forgiveness and to allow the Board of Selectmen as applicable to expend such monies as they become available and pass any vote relating thereto? Requires a 3/5 ballot vote.

Article 28 – Waste Disposal Special Revenue Fund (Fund 18)

Shall the Town of Raymond vote to raise and appropriate the sum not to exceed Fifty Thousand Dollars (\$50,000) for the purpose of paying for any Town costs associated with the transfer station and permit program with said funds to come from the Waste Disposal Special Revenue Fund also referred to as Fund 18. Should this Warrant Article be defeated, the Town would not be able to continue with the Transfer Station Permit Program due to the absence of legislative authority to legally access the funds. (Majority Vote Required).

This is the second payment negotiated in the Towns best interest. These funds shall be paid from the unassigned fund balance. And no amount will be raised from future taxation. Further, to name the Board of Selectmen as agents to expend from said fund. (Majority Vote Required)

Please read this letter aloud at the Board of Selectmen meeting on January 2, 2024, or at your next meeting.

This correspondence is written in response to the suggestion that citizens respond to the Board of Selectmen's (BOS) discussion of Social Services Warrant Article during their meeting on December 26, 2023.

I believe it is important to support each of the agencies that came before the BOS last fall to explain their request for financial support. Each nonprofit provides important and valuable services to the citizens of Raymond. I am pleased to understand that you want to support CASA, RCFY, Ray-Fre Senior Center, and Rockingham County Nutrition (Meals on Wheels). Allow me to explain the importance of funding the other agencies serving Raymond residents in need, which you considered eliminating from the ballot at that same meeting. The numbers regarding residents served by the following nonprofits are from a pre-Covid survey conducted by Voter Guide volunteers in order to provide details to voters:

HAVEN – requests \$2,000 to prevent sexual assault and domestic violence to individuals and families. HAVEN provided 75 Raymond residents with over 500 hours of service through their 24-hour support program and over 100 shelter bed nights. Cheryl Van Allen, Business Administrator, HAVEN. www.havennh.org 436-4107

Chamber Children's Fund requests \$2,000 – provided winter clothing, bedding, vouchers, and gift cards to needy children as well as direct funding to school nurses. Between 2013-2018 the Fund gave 764 vouchers to Raymond families; in 2018 vouchers were given to 145 children in Raymond from 70 families. Christine J. American Red Cross requests \$1250 – provides disaster assistance for housing, medical needs, and prescriptions.

Waypoint at the Richie McFarland Center requests \$3,250 – provides therapeutic services for preschoolers. Previously, the amount requested of the Town of Raymond represented 5% of the annual cost of weekly home-based therapies for one child and his or her family. The

agency relies on towns to provide approximately 6% of total agency funding. Peggy Small-Porter, Executive Director, Richie McFarland Children's Center. www.richiemcfarland.org 778-8193. For every dollar spent on early intervention services, school systems will later save anywhere from \$4 to \$7 in special education costs. Peggy Small-Porter, quoting Educational Resource and Information Center. Children who participate in early intervention programs prior to kindergarten are more likely to graduate from high school, hold a job, live independently and avoid teen pregnancy or delinquency. Peggy Small-Porter, quoting American Academy of Pediatrics.

Southern NH Services requests \$2,000 – provides services to low-income individuals and families to prevent poverty and homelessness. One year, the program helped 1,060 Raymond households receive services – predominantly fuel and electrical assistance, weatherization, food pantries, and Women, Infants and Children (WIC) Nutrition. Keith Bates, Project Manager, Rockingham Community Action. www.snhs.org 895-2303

One Sky Community Services requests \$2,000 – provides help to people with Developmental Disabilities and Acquired Brain Disorders so they live as valued and participating members in their communities. Services provided to Raymond residents were detailed at the BOS meeting for Social Services agencies.

Child Advocacy Center requests \$ 1,500 – provides evaluations of alleged child abuse for youth. In Raymond in 2018, a total of 74 forensic interviews and consultations were conducted, with the number of cases continuing to increase from Raymond (and the county at large). A forensic interview is a structured conversation with a child intended to elicit detailed information about a possible event(s) that the child may have experienced or witnessed. The funding directly supports the Forensic Interviewer position. Services have been on the rise in Raymond and other Rockingham County communities, in part because of the opioid epidemic's effects on children & families. Loree Sullivan, Family Support Specialist, Child Advocacy Center of Rockingham County. www.cacnh. org 422-8240

The requested cost is \$14,000. The estimated tax impact on a \$200,000 house is about one cent (\$0.0105).

During BOS meetings, these nonprofits organizations have been referred to as "charities." However, SCORE (Service Corps of Retired Executives) established in 1964 by the Small Business Association which offers mentoring to startups or similar small businesses, defines a "charity" as promoting educational or religious purposes, providing funds to help support medical research, or promoting a cause that in some way could benefit the general public. In 99% of those cases, SCORE states that such entities are known as a charity. If not, it is a nonprofit. The organizations above offer services to children and adults with specific needs and therefore, are nonprofits.

To eliminate any of these agencies from consideration by the voters is a bad decision because it is up to the voters to decide. Historically, the voters have elected to support nonprofit agencies that support our citizens. Please <u>do not</u> separate the nonprofits into separate Warrant Articles. In 2019, this approach was extremely unpopular and resulted in voter fatigue given the 13 separate Social Services articles on the ballot. I hope that the Select Board will set aside their own opinions to serve the town.
